Hourly rates may vary according to the seniority and experience of counsel, and the complexity and urgency of the case. The current rate of VAT will be added to all fees (unless exemptions apply). We will tailor a fee structure to suit your individual requirements and give you an indication of the strength or weakness of your case or likely level of award before you embark on costly litigation.

Factors which might influence the timescale for the provision of legal services may include: the complexity of the matter, the barrister's availability, the volume of documents which need to be assessed, the need for further documents or information, and court waiting times.

Our barristers will only accept work if they are available to meet the client's requested deadline for the completion of the relevant directions. Sometimes, such as when attendance is required on the return date for an injunction, their availability cannot always be assured due to pre-existing obligations. In those circumstances, an alternative member of chambers will be put forward.

As you must appeal a decision from the Home Office (that carries a right of appeal) within 14 days (if the person concerned is in the UK) or 28 days (if outside the UK), please complete the direct access form which you can access here or, alternatively, contact our immigration clerks as soon as possible using the contact details below. If you need advice and/or representation at short notice, please contact the clerks as soon as possible: our barristers will aim to advise you and/or represent you at a hearing, where possible.
